COVID-19 Updates

COVID Treatment Guidance

September 22. 2020

The ECC has approved the updated guidance for the Management of Adult Hospitalized Patients with COVID-19.

<u>Here is the link to a PDF with a brief explanation</u> (within the PDF is another link to the actual document). It provides recommendations pertaining to the decision to admit, testing and treatment with antibiotics, antivirals, and steroids.

COVID-19 data collection

As you may be aware, we are collecting data on all patients undergoing COVID swab testing as part of the Canadian Emergency Department COVID-19 Rapid Response Network. The objective of this network is to systematically collect data on all ED patients with suspected COVID in order to develop epidemiologic evidence and evidence-based clinical guidance for the management of ED patients with suspected COVID disease.

Blue data collection forms are available in COVID patient care areas at RGH, PLC and SHC. Hopefully soon at FMC. If possible, please complete these forms on any patient undergoing COVID testing in the ED. The back page is only for patients with suspected COVID who are intubated in the ED.

Your assistance is greatly appreciated--this is our best chance to develop evidence to guide ED decisionmaking for our patients as the pandemic evolves.

N95 Fit Testing

Please ensure that you are fit-tested for a model of N95 that is available in your ED. (Site chiefs have information on testing availability)

Background

AHS's N95 procurement strategy has resulted in the Emergency Departments having a continuous supply of this scarce resource. Unfortunately, the models keep changing and we are responsible for updating the fit testing process.

Currently available models include the 8210, 1860s, 1804 and the Dasheng DT3CZ.

Please ensure that you are fit-tested for a model of N95 that is in your ED. (Site chiefs have information on testing availability)

It would be best if you carried proof of fit-testing as well. If you are not fit tested, you should not be doing AGMP's (such as intubation).

Policy for Resident Assignment to Staff Traded Shifts

As we transition from Medevision to MetricAid, we wanted to take this opportunity to remind staff of the policy for trading shifts to which residents have been scheduled. In brief, when an FRCP or CCFP-EM resident is assigned to your shift and you are trading or giving the shift away, we ask that you please notify the resident assigned. The resident will then have the option of moving alongside you into your new shift if their schedule allows, or retaining the original shift. In Calgary shifts are assigned on a preceptor based system as opposed to a shift template model. This is done to improve the staff learner relationship to allow higher quality feedback

and to promote graded autonomy. If you do not have the resident's contact information, please contact our program admin, Madhavi Talasila at <u>madhavi.talasila@albertahealthservices.ca</u>.

Additionally, we'd like to remind everyone that residents are not to be viewed as a commodity and offered as incentive to trade a given shift. Thank you all very much for your ongoing contributions to the residency programs, and your attention to this matter.
