New Role for RAAPID MD in the transfer-in of patients to see a specialist

This link provides an overview of the new transfer policy for specialist patients. I would like to provide some editorial comments. This is a major operational change. It starts today. We have decided to take responsibility for those patients who arrive in our ED having been accepted in transfer by a specialist colleague. Please treat these patients as our own. The accepting specialist is still expected to see them in the usual time frame, and is accountable for medical care in their area of expertise and to help facilitate a disposition if admission under their service is not appropriate. However, ED MD's are uniquely poised to manage clinical deterioration in our department; we are also experts in the disposition of complex patients. Adam Oster's QA process has identified multiple adverse serious patient outcomes over decades, that arose because transferred-in patients did not have an ED MD on their care team in the ED.

This is not expected to result in extra transfers to the ED (we will be watching).

This process is not applicable to patients who are asked to attend an ED by a specialist to see that same specialist. (this should be a rare event and is discouraged)

You will be on calls where you don't see a clear role for yourself in the care of the patient. Your involvement will be minimal in these cases. We currently don't have a good way of filtering out these cases, but we will monitor things as the process gets underway.

This will result in a few more RAAPID calls for each of us. If the logistics of adding these extra calls creates operational difficulties, we will adapt.

Please discuss billing issues with your Billing Group Representatives.

I would like to thank Adam Oster and his team for the leadership he has provided in identifying this issue and "operationalizing" a solution.

Mental Health Emergency Physician Liaison (MH-EPL) and overnight psychiatry consults at FMC

Jennifer Nicol has taken the new role of the Mental Health Emergency Physician Liaison (MH-EPL) with the objectives to optimize the delivery of mental health services in our departments, using evidence based best practices, working closely with our colleagues with psychiatry. She is currently working on a standardized approach to medical clearance of our psychiatric patients, and a methamphetamine induced psychosis treatment pathway.

What I ask of you, is to please contact me with any concerns or questions you have related to mental health care delivery in our EDs, with ideas you have for process improvements, or with any questions. Your feedback will help guide issues that I tackle over the next year, and is greatly important and appreciated. I will be using the weekly newsletter to send out updates, so please stay tuned!

PLC/FMC overnight psychiatric consults:

If a patient is "medically cleared", meaning sober and medically stable, with an active psychiatric concern that requires their expertise for disposition (i.e. safe discharge or admission), then it is appropriate to consult the resident on call overnight, and not hold the patient until morning. The psychiatry residents are aware of this at both PLC and FMC, and should you encounter any pushback or resistance to them coming in, please email me directly and let me know.
