COVID-19

High-Risk Nature of Pregnant COVID Patients

We would like to bring to your attention a reminder about the high risk nature of pregnant COVID patients. Presentations of patients with COVID who are pregnant seem to be more common in this wave.

Please have a low threshold for admitting them. Here are the answers to a few common questions that we posed to Dr. Colin Birch, Department Head of O and G.

1- Aside from the usual obstetrical indications for admission, when should you consider admitting a pregnant patient for COVID?

Answer: Maternal Early Warning Triggers. One yellow trigger is sufficient for admission (See MEWT below*)

2 - Does gestational age matter

Answer: No, any gestational age has the propensity for deterioration although more advanced gestations with the changes in physiology seem to be the most likely to require ICU

3 - Who does the initial consult go to if the request for admission is for MEW triggers? Answer: MTU admit with OB consultation

4 - Does it matter which hospital they initially present to? Answer: Between 23 and 32 weeks should be admitted to FMC

Change of Practice of Chronic (non-life Sustaining) Non-Invasive Ventilation:

We continue to see increasing COVID-19 transmission and hospital admissions as part of the pandemic's fourth wave. In response we are reinstating the Non-Invasive Ventilation (NIV) in Acute Care during COVID-19 Pandemic guidance document. This reinstatement is effective immediately. This document replaces all previous guidance specific to non-invasive ventilation (NIV). Please update staff accordingly.

We continue to closely monitor the evolution of the COVID-19 pandemic. Any opportunity to revert to less restrictive Chronic NIV practices will be communicated in a timely manner as the situation evolves.

-Calgary Zone Emergency Operations

Two COVID related updates from the recent CMO communication:

1) AHS is implementing a **policy of immunization for workers for COVID-19**. A finalized policy is expected in the coming days.

AHS workers, including medical and midwifery staff, are required to be fully immunized no later than October 31. This means the latest a second dose could be administered to still meet the deadline is October 16. To be able to have a second dose no later than October 16, any healthcare workers who haven't yet had their first dose need to make plans to do so very quickly. 2) Eye Protection:

Executive Summary - For us in the ED, they recommend eye protection in general, and they require it for close contact of "screen positive" patients but if you are fully vaccinated, you will not be quarantined for contact with COVID-19 patients.

Background -<u>"Eve protection is always an important component of Contact and Droplet</u> precautions, in addition to a medical mask, gloves and gown. As such, province-wide, continuous eye protection must be maintained for all staff and physicians:

- In COVID-19 units.
- In settings experiencing COVID-19 outbreaks.
- When providing care or services within two meters of a patient with COVID-19, suspected COVID-19 or who is experiencing symptoms consistent with a respiratory tract infection.

For those who are fully vaccinated, as updated in the eye protection guidelines in May 2021, eye protection may be discontinued in all other instances.

Those who are fully vaccinated will not be quarantined following contact with COVID-19, if not wearing eye protection (providing they remain asymptomatic)."
