Disposition escalation process over Stampede

We are planning to trial a **4-hour disposition escalation process** during Stampede. When our departments are in EMS emergent offload, we will be asking consultants to provide disposition decisions within four hours of consultation. This will include staff-to-staff discussions at the 4 hour mark.

The exact process and details will be shared with ED physicians and other Department Heads/Operations people (likely tomorrow) as we finalize the last pieces. We recognize that this is new and may catch some consultants off guard. Our goals at this stage are twofold:

- 1. To pilot the process and see how it works in practice.
- 2. To raise awareness among consulting services about the pressures the ED is facing during EMS emergent offload situations.

As with any new process, we expect there may be challenges or unforeseen issues, and we know there will be opportunities for improvement. Your site leads asked us to do this two weeks ago and

and/or your site leads.

Thank you for your patience and collaboration as we work together to improve flow and care for our ED patients.

Also, thanks to Mike Szava-Kovats who has offered to do a small evaluation of the pilot.

ED Frequent Visitors Program

Members may have heard rumors of a recent threat to the ED frequent visitors program headed up by Dr Christine East and Ken Mont. We have had a <u>really</u> difficult time finding the appropriate amount of leadership funding to support this <u>very</u> important work. I am thrilled to announce that through the collaboration of Dr Mark Anselmo (ZMD) and Dr Richard Leigh (Senior Associate Dean Faculty Affairs) we were able to temporarily borrow an AMHSP as of July 1, 2025. This gives us the interim solution we need until our EM AMHSPs come on board. On that same note, Alberta Health confirmed the budget for the 6 AMHSPs that I previously mentioned were on hold and I am hopeful that things will move forward on those positions as soon as possible.

Go-live June 17


 For Form 1 and Form 2, the Add Signer Name field will replace the Provider name field in the left panel.

Anonymous Patient Workflow Pilot

- Go-live June 23, FMC only
- A new workflow implemented by HIM to update the identity of unidentified patients during the admission rather than after discharge
- Updates will be coordinated by HIM during business hours (M-F, 09:00-15:30), during a time when the patient doesn't have planned medications/procedures, etc.
- HIM is unable to merge the records when another user is in the chart. HIM can trigger a
 Close Chart Request message to users that are actively working in the chart, so they can
 continue with the merge:



- It will take between 2-10 minutes to complete the merge.
- Upon Merge and Demographic update, MRP (current Attending Provider) tasked to review chart for clinically significant impacts including Admission medication reconciliation, Allergy history, Warnings, and other clinically significant changes. This will be sent to their In Basket.
- Task is rescinded if patient is discharged.

Clinical Pharmacology and Toxicology Pearl of the Week

This week's Clinical Pharmacology and Toxicology pearl is on drug-induced elevations in lactate. <u>CPT pearl drug-induced hyperlactatemia.pdf</u>

Drug-induced elevations in lactate are typically a type-B hyperlactatemia, resulting in tissue hypoxia that is independent of tissue oxygen availability.

We are thrilled to have our new residents join us and look forward to their unique perspective on the challenges ahead!

Research

Beginning July 3, we will be starting data collection for a national, multicenter observational study (led out of Calgary!) to develop a new risk prediction tool for low-risk chest pain patients that performs better than existing tools like **HEART**, **EDACS** and others.

In patients with very low troponin concentrations, the risk of short-term adverse cardiac events is **0.5-1%**. But nationwide we refer about 1/4-1/3 of low-risk chest pain patients for outpatient consults/further testing. This leads to long wait times for patients who might actually benefit, and close to \$200 Million in unnecessary healthcare expenditures. Please help us develop better-performing tools to accurately identify which patients might benefit from downstream testing, and which ones do not need further testing.

Starting on July 3, **at RGH, FMC and SHC**, you will see a Best Practice Alert in the Dispo tab for patients with chest pain whose Troponin concentration is <115ng/L (we're trying to capture both low risk patients as well as those who may have nondiagnostic troponin concentrations/Unstable angina-type patients). The BPA will have a hyperlink to a data collection portal that will quickly take you through inclusion/exclusion criteria then, if the patient is eligible, you will be asked to complete an electronic data collection form that typically takes **60-90** seconds.

We will be starting to do monthly gift card draws for MDs who complete the data collection forms for this study as well as the syncope study. The more forms completed, the better your chance of winning!

Thanks for your help with this project that will lead to substantial improvements in the quality of care we provide to patients with suspected coronary disease.

PACS Changing - TRAINING REQUIRED

With the province-wide rollout of Connect Care and the availability of diagnostic images through XERO, broad access to PACS is no longer necessary. Access to PEI is now restricted to specific user groups, including **emergency providers**.

To gain access to PEI, all users must complete a **1-hour eLearning module** available on **My Learning Link**. Please note that this module will not be accessible to Calgary Zone learners until **June 30th. 2025**.
