Class Location	Classes will be conducted online via zoom, as a combination of asynchronous and synchronous sessions.		

This course will take place **online** via Desire2Learn (D2L) and Zoom. To best succeed in the course, students will be required to participate in the asynchronous learning tasks (including viewing pre-recorded lectures) and synchronous Zoom sessions. When unable to participate live due to the time difference or unforeseen circumstances, inform the instructor in advance and propose and implement propose an alternative participation activity (e.g., watch the recordings, submit a brief reflection, and actively contribute to the follow-up online discussion). There will be weekly synchronous Zoom sessions throughout the term (as indicated in the course schedule).

COURSE INFORMATION/DESCRIPTION OF THE COURSE

This course teaches research methods relevant to medical imaging. Lectures will cover basic statistical analysis and advanced statistics relevant to medical imaging analysis. Students will learn how to critically evaluate medical imaging literature. The class will overview basic image analysis techniques common to different modalities (e.g., assessing reproducibility), and provide a basic introduction to analysis techniques relevant to multiple imaging disciplines (e.g., machine learning, finite element analysis).
