Practical techniques of human autopsy dissection will be demonstrated and practiced. The practicum is divided into five (5) modules, each with progressive responsibilities to attain competence in autopsy dissection and morgue procedures.

 - Health and safety measures in the morgue
 - External examination and evisceration of bodies in accordance with autopsy consent (limited and complete autopsies)
 - Facilitation of ancillary testing, including but not limited to histology, genetic testing, and electron microscopy
