## Prerequisite/Co-Requisite:

Second year or higher standing in the BHSc Honours program.

## **Course Description:**

A survey of underlying ideas concerning the objectives, methods, ambitions, and responsibilities of the natural and social sciences

## **Overarching Theme**

The overarching theme for this course is science's role in society. Students will develop an understanding of this role by engaging with such philosophical ideas as...

- Demarcation: What distinguishes genuine science from pseudoscience?
- Inference: How does observational evidence give us reason to accept scientific theories?
- Theory Change: When a theory is succeeded by a new one, how should we understand the relationship between new and old? What is scientific progress?
- Critiques of science: Science is generally seen as a source of emancipation that has freed us from a superstitious world view. Is this still true of science? Or can science be oppressive?

The course will begin with lectures on the above concepts. Students will then apply these ideas as they explore such issues as the impact of technological change and public trust in science.

## **Global Objectives**

The main goal of this course is to develop a toolkit of resources for thinking about science and to use that toolkit to make sense of science's role in society.

## **Course Learning Outcomes**

By the end of this course, students should be able to:

- Grasp fundamental conceptual issues about science such as demarcation, confirmation, realism, and progress
- Analyze original works by philosophers of science and other scholars
- Lead a discussion on a scholarly paper
- Apply conceptual tools to elucidate problems at the intersection of science and society

# Brief Description of Graded Items (detailed instructions available on D2L)

Paper Analysis I: A maximum 400 words paper articulating the argument made in one of the readings chosen by a classmate for that classmate's Paper Discussion I. Due the evening BEFORE paper is to be discussed in class. (Note that the course instructor will match you to a classmate's reading)

Paper Discussion I: Lead a ~30-minute discussion of a reading selected by the student and approved by the instructor. (See Course Schedule)

Paper Discussion I Planning Document: a description of the reading you will focus on in your Paper Discussion I, 1 or 2 learning objectives and an explanation of how the reading's topic relates to course themes. Due 1 week prior to your in-class Paper Discussion.

Paper Analysis II: A maximum 600 words paper articulating and evaluating the argument made in one of the readings chosen by a classmate for that classmate's Paper Discussion II. Due the evening BEFORE paper is to be discussed in class. (Note that the course instructor will match you to a classmate's reading)

Paper Discussion II: Lead a ~60-minute discussion of a reading selected by the student and approved by the instructor. (See Course Schedule).

Paper Discussion II Planning Document: a description of the reading you will focus on in your Paper Discussion II, 2 or 3 learning objectives and an explanation of how the reading's topic relates to course themes. Due 1 week prior to your in-class Paper Discussion II.

## A Note regarding Writing Assignments:

Writing skills are important to academic study in all disciplines. In keeping with the University of Calgary's emphasis on the importance of academic writing in student assignments (section E.2 of 2021-22 Calendar), writing is emphasized, and the grading thereof in determining a student's mark in this course. Competence in writing entails skills in crafting logical, clear, coherent, non-redundant sentences, paragraphs, and broader arguments, as well as skills with the mechanics of writing (grammar, spelling, punctuation). Sources used in research papers must be properly documented.
