COURSE INFORMATION/DESCRIPTION OF THE COURSE

Policy sets direction for health and health care. This course will be an interactive seminar format which will address formulation, implementation and consequences of health policy. It will be informed by health policy topics and issues, such as primary health care, service delivery models, pharmaceuticals, e-health etc. While the course will focus more heavily on the context of public policy and systems of care within Canada, an international and comparative lens will be use to challenge and contrast underpinnings of health policy in Canadian jurisdictions.

LEARNING RESOURCES/REQUIRED READING

Students will receive presentation and reading assignments in advance of each session. The readings will be public reports, published papers, and selected key documents in Canadian health care.

COURSE OBJECTIVES/LEARNING OUTCOMES

The objective is for students to understand and develop analytic skills for healthcare policy. The primary vehicle for learning will combine these resources with individual student interests and initiative. Hence, a directed-studies approach will encourage individual students to sharpen their independent and critical skills, while participating in learning through sharing, with class input, presentations and papers, and with input and critique by other course participants & instructors.

The learning objective is to understand, analyze & communicate the nature, importance and implementation of health and healthcare policy.
