From the Department Head

There will be two major organizational changes occurring on April 1. One is the formation of a new Region 3, which expands the Calgary Health Region. The second is the transfer of AMHB clinical mental health services to the new Region 3. This will bring the Claresholm Care Centre and a number of rural mental health clinics together with the five mental health clinics in the Calgary Health Region into one organizational structure. The intent is to make the change with no immediate discernible change to clinical services.

The transfer of services from Alberta Mental Health Board to Region 3 does not address the service delivery problems for mental health services in Southern Alberta, which were identified in the Mazankowski report. Addressing those concerns is supposed to be part of a second round of mental health restructuring. Planning for this restructuring will begin as soon as the transfer of services is complete.

The Royal College of

Physicians and Surgeons of Canada review of residency training programs has been completed.

The Department of Psychiatry was given full accreditation for the next six years. During the last year, Dr. Bev Adams and the Residency Training Committee have made a few key changes to address the concerns of the last internal review. They deserve our thanks and congratulations. In addition, the accreditor was

number of clinical faculty who came to meet with her. The quality and commitment of our faculty are critical to the


> success of the Residency Training Program. Mythanks to all of you.

Undergraduate Education

Undergraduate teaching continues to keep preceptors and seminar leaders busy on all 4 sites. Clerk numbers this year will increase from 97 to 108, increasing the average per block size from 10 to 12, keeping 4 preceptors on the go at all 3 main sites.

Of note, a couple of faces have already changed in clerkship:

- Dr. Carlos Tesler-Mabe has taken over the role of Site Coordinator for the Foothills from me.
- Dr. Hussam Bawa has agreed to take over the Site Coordinator role at PLC from Dr. Nandini Singh. Many thanks to Dr. Singh and Helen Field for their many years of support to the legions of clerks that have gone through the PLC with their assistance.

The undergraduate MIND course will run September 26 to October 20, 2003. Based on feedback from both the committees and the students, and with the blessings of

the Faculty's Undergraduate Curriculum Committee, we are continuing to revamp the curriculum to incorporate increased teaching in the areas of geriatric and child & adolescent, as well as updating all chapters in the core document. Dr. Chris Blashko is overseeing changes to the core document and urges current lecturers to contact him (943-8704) to discuss revisions. Due to the increased size of our medical school (from 100 to 115), we will require 23 small group leaders on all 3 sites to conduct the clinical experience portion of the MIND course - further information will be sent out in late March.

We are also considering a departmental Undergraduate Retreat in early May - look for information to come in the near future. This retreat will address both the development of teaching skills and updating our current test question banks.

Inpatient Psychiatry



Updates in Quality Improvement

Since the establishment of the Quality Council for Mental Health and Psychiatric Services a number of Quality Improvement projects have begun to get under way. One of the most unique is the 8th & 8th Transfer Project. The 8th & 8th Transfer Project is piloting a new transfer process for mental health patients suitable for the Short-Stay Unit. The previous process for patients deemed appropriate for the service involved having patients go through on average three assessments: one at 8th & 8th, one at Psychiatric Emergency Services and another

upon arrival at the Short-Stay Unit. This often resulted in long delays and decreased capacity in Psychiatric Emergency Services. The pilot process to alleviate wait times and delays involves having the Admitting Physician at the Short-Stay Unit approve the mental health assessments from 8th & 8th without those patients having to be re-assessed prior to admission on the Short-Stay Unit. Currently, this role is being fulfilled by Dr. Thomas MacKay.

"Essentially, my role in the pilot is to make sure that the referrals are appropriate", says Dr. Mac-Kay. To date, eight patients have gone through the process and wait times and delays have decreased significantly. Furthermore, "the assessments are the same quality we get from PES", says Dr. Mac-Kay. The pilot will continue until May 2003 when the 8th &8th Transfer Project QI team will reassess and make recommendations to the Quality Council for implementation and future monitoring.

This occurred in a timely fashion: when clients are in need of winter wear. Christmas 2002. the ACT team held their Christmas party in Kananaskis, at the William Watson Lodge. Each client put together a wish list, and with the donations received from numerous different corporations, we were able to purchase at least



one gift for each client from their list. Each client also received a stocking with some goodies inside. The clients then received a homemade Christmas dinner with all the fixings that was prepared by staff. The staff and clients enjoyed a great outing; wonderful bus ride, and a warm meal. Great fun was had by all.

The clients in turn were able to share in the holiday spirit of giving. Some of the gifts that we received from grateful patients included soft drinks, home made cakes, chocolates, brushes, shampoo, chips, and other treats. It is really heartening to experience this atmosphere of sharing from both sides. Let's hope that this act of giving will continue throughout the year.

Forensic Psychiatry to Remain Province-Wide Program

Forensic Psychiatry became a province wide service in August 2000. The Alberta Mental Health Board and the Calgary Health Region collaboratively managed services in Southern Alberta. The rationale for the provincial program was to allow the delivery of highly specialized services to Albertans in all health care regions in a provincially coordinated fashion.

Throughout the recent mental health transitions Forensic Psychiatry, as other areas in mental health, have remained committed to providing the best service possible to our patients and stakeholders. In recent years we have seen a significant expansion of our Forensic Adolescent Program and

the implementation of Community Geographic Teams providing dedicated resources to the health care regions in Southern Alberta. We have also seen the development of a number of provincial initiatives with respect to family violence, diversion and young offenders. In this last year we have also seen the development of a provincewide Telemental Health Forensic Psychiatry Service. In the future, we look forward to an expansion and eventual relocation of the Forensic Assessment Outpatient Service within the community. Significant work has also been put into a proposed expansion of Forensic Inpatient Services in a free standing mental health facility in Calgary.

Further to the governments most recent announcements regarding mental health services, the Provincial Forensic Psychiatry Program will continue to be governed by the Alberta Mental Health Board as a province wide program. Service delivery will be contracted to the regional health authorities under contract with the Alberta Mental Health Board.

We look forward to working in a collaborative fashion with our stakeholders, ensuring that Forensic Psychiatric Services will continue to be delivered in a comprehensive and coordinated manner.

AMHB / CHR Integration

Beginning April 1, a new health region will be formed incorporating Calgary, the former Headwaters and part of Region 5. An additional challenge for Mental Health will be the migration of many of AMHB's former services into the new region.

There are psychiatrists who have had privileges only with Calgary, only with Headwaters, or only with AMHB. Working groups have been established to manage the issues of the medical staff in the new region. With respect to AMHB, a working group met in the fall of 2002. This group developed a set of principles to deal with the transition of medical staff into the regions. The Minister approved these principles recently.

Privileges

- A. Prior to transfer, AMHB medical staff privileges will be grandfathered by the relevant RHA.
- B. Following the transfer, AMHB medical staff will abide by the relevant RHA Medical Staff Bylaws, Rules and Regulations
- C. Following the transfer, AMHB medical staff credentialing, privileging and appeal processes will follow the relevant RHA processes.
- D. AMHB medical staff will be integrated in the relevant RHA medical governance structure.

Compensation

A. AMHB sessional, administra-



- tive, and on-call budgets will be transferred to the relevant RHA and maintained according to current AMHB physician compensation practices for 2 years or prior to 2 years when a Provincial Mental Health Strategic Plan is in place.
- B. AMHB medical contracts will be maintained by the relevant RHA for 2 years or prior to 2 years when a Provincial Mental Health Strategic Plan is in place.

A steering group is being formed to effect a smooth transition. Any questions or concerns at this time would best be directed to Dr. Don Addington, Dr. Rollie Nichol, Dr. Gerry McDougall, or Dr. Doug Watson.
