# 2018-2019 was a year of significant milestones



### Who we are

CME&PD offers a broad range of evidence-based learning opportunities to physicians, other healthcare providers and the public in a variety of formats from face-toface, to online and blended learning.

Our core activities include developing and providing educational programming, accreditation of internal and external professional development activities, physician assessment and remediation, and educational scholarship. Annually, we develop and deliver between 40-70 CME&PD courses to approximately 5,000 registrants.

CME&PD at the University of Calgary is fully accredited by the Committee on Accreditation of Canadian Medical Education (CACME) and is an accredited CPD provider for The College of Family Physicians of Canada (CFPC) and the Royal College of Physicians and Surgeons of Canada (RCPSC).

Develop internal programing and review external applications to accredit professional development activities for physicians as an accredited CPD provider for the Royal College of Physician and Surgeons of Canada and the College of Family Physicians of Canada.

Support physician self-assessment and feedback through the Physician Learning Program (PLP) and remediation through Alberta Physician Assessment Support Services (APASS).

Conduct educational research and develop educational innovations focused on physician learning, program evaluation, self-assessment, and physician performance assessment.

### A Year in Summary

### **CACME** Accreditation Renewed!

On November 26, 2018, CACME conducted a site visit assessing our compliance with the accreditation standard related to institutional governance, educational programming, overall organization and continuous improvement activities. Based on our self-study submission, supporting documentation, and key stakeholder interviews, CME&PD received full accreditation for an additional eight-year term (2018-2026). This achievement is foundational for achieving our strategic objectives: Sustainability, Excellence in Education, Community Engagement, and Scholarship.

### Sustainability

In the past year, CME&PD offered more face to face, online and blended learning courses, attracting more attendees and ending our fiscal year in a surplus position. The launch of a new registration platform, Destiny 1, has enabled in depth demographic information supporting the implementation of our new targeted marketing plan. Our newsletter subscribers, website users and social media followers reflect our continued community engagement.



### **Educational Excellence**

CME&PD strictly adheres to the National Standard for Support of Accredited CPD Activities ensuring evidence-based and unbiased medical education. However, as a longstanding educational leader, we strive to go beyond the national standard by elevating CME owned or co-developed courses to our own CME 2020 Standards. This includes developing programs with a formal needs assessment, learner-centered objectives, evaluation of learning outcomes and enduring content. Course evaluation reports consistently convey high satisfaction with our educational offerings. Annually, we conduct a global needs analysis involving academic leaders, faculty, frontline providers and stakeholders to provide a strong foundation for future course development. As a result, **10 NEW** face-to-face, online and blended learning courses were developed and delivered to meet the educational needs of our specialists, family physicians and rural healthcare providers.

#### With Health Care Providers:

Inter-professional healthcare providers are regularly included in course planning committees, especially with our longstanding flagship courses: Emergency Medicine for Rural Hospitals, Pearls for Family Practice and Calgary Therapeutics. In fact, between 10-50% of our course attendees are other healthcare providers.

#### With the Province

The development of the Wise Prescribing and Deprescribing: Opioid Skills for the Frontline Clinician and the roll-out of Alberta Opioid Dependency Treatment Virtual Training Course was a direct response to Alberta's opioid crisis, reflecting our commitment to medical education that meets community and societal needs.

This past year, CME&PD also collaborated with the College of Physicians and Surgeons of Alberta (CPSA), Alberta Health Services (AHS), and Choosing Wisely Alberta (CWA) to deliver or develop medical education addressing doctor-patient relations, physician practice improvement, and increased appropriateness of investigations and treatments.

PLP creates actionable clinical information and engages with physicians, teams, and partners to co-create sustainable solutions to advance practice.


### Strategic Priorities of the PLP



### **The CAFF Model**

<u>The Calgary Audit and Feedback Framework</u> is a practical, evidence-informed approach for the design and implementation of audit and feedback in groups. The four factors: relationship, question choice, data visualization and facilitation are integral to this approach and this tool helps physicians move from reacting to their practice data and towards planning for a positive change.



### **FMEC - CPD Report**

The Future of Medical Education in Canada – Continuing Professional Development report has revitalized the vision for CPD in Canada (<u>www.</u> <u>fmec-cpd.ca</u>). It challenges us to support physician learning and practice improvement in a manner which is responsive to patient and community needs, is informed by scientific evidence and practicebased data, and is designed to measure improvements in patient care and population health while respecting the work life of health care providers.

Based on the FMEC-CPD recommendations, CME&PD will continue to evolve, placing greater emphasis on scope of practice, teambased care, and interprofessional CPD, while building opportunities to enhance communities of practice and commitment to lifelong learning.
