RESEARCH – Important Information re: Launch 4 Research Training and Conversion

Research Staff ILT: Virtual Training Dates

- Monthly training sessions for sites live in Connect Care continue to be offered.
- Additional dates for Launch 4 have been added and enrollment instructions have been emailed to users requiring training.

Research Conversion Classroom:

- Virtual Research Conversion Classroom sessions will run as per the following:
 - ❖ **WHEN:**
 - May 9/22 to May 13/22
 - May 16/22 to May 20/22
 - ❖ **TIME:**
 - 0830h to 1030h
 - Maximum of 15 attendees per session
 - ❖ Virtual office support 30 minutes in the afternoon each day.

How to Register for Research Conversion Classroom when you receive a Registration Request email:

1. Ensure at least ONE team member signs up for a virtual conversion classroom session to complete conversion activities for your studies (**make sure you have all listed information available during your virtual classroom session**).
2. All team members must complete the self-directed Research Conversion e-learning on MLL
3. Have a back-up plan in case your delegate is unable to attend the virtual conversion classroom
4. Test your Connect Care login

RESEARCH – Important Information re: Launch 4 Research Workflow Walk Through (WFWT)

This event will be scheduled one week prior to launch and will cover the main workflows taught in training and completed during the research conversion classroom. It will be a combination of your clinical and research training. Topics will include:

REPORTING and ANALYTICS Launch 4 – Executive Launch Dashboards

The Executive Web Launch Dashboard is specifically designed to assist Executive Operations Leaders (SOO, ED, CMIO Leads) with monitoring the success of Launch. The dashboard contains high-level metrics across a number of applications areas to provide an at-a-glance view of key information for early identification of launch/adoption issues. The dashboard contains information for all sites live on Connect Care and allows for easy comparisons between sites and waves.

Launch 4 Senior Operating Officers and Executive Directors have been identified and assigned the Executive Operations/CMIO Leads role centrally by the Connect Care Project team. They will receive notification and information about Orientation sessions, specific for their role, by email.

Anyone else (Mangers, Directors, etc.) wanting access to this dashboard, should have the **Clinical View-only plus Basic Reporting** role assigned and complete the required training. More information can be found in the [Course Catalogue](#).

Contraindicated Medications – Optional Functionality – New Workflow

Instead of using a generic medication grouper to configure this functionality for your study, a NEW medication grouper will be built specifically for each study (allowing you to set up both specific drugs and/or drug classes).

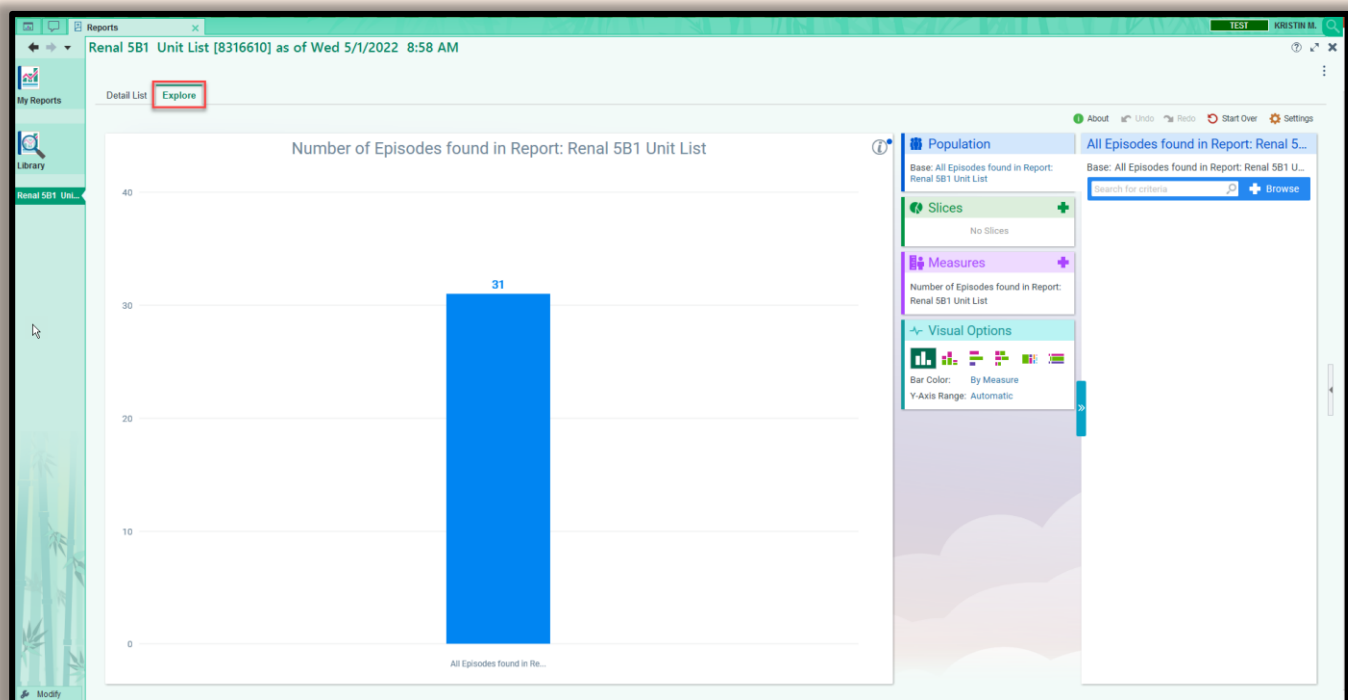
REPORTING and ANALYTICS – Triple Upgrade coming in April!

The Connect Care system will undergo a routine upgrade on April 14, 2022. With the update comes many new features and updates to existing features. To find out how the upgrade will affect the reporting tools in Connect Care, go to [MyLearningLink](#) and register to review the **Epic Spring Upgrade - 2022** e-module. The module provides a review of general upgrades applicable to all end users, then allows you to choose to review specific applications. Select 'Cogito' to review upgrades to the reporting tools in Connect Care. Many new features are available with the upgrade including the one highlighted, below.

The **Explore** Tab in Reporting Workbench allows end users to create their own summaries with the SlicerDicer interface. The biggest differences between summaries in the explore tab and summaries created in the Report Settings are as follows:

1. Explore tab summaries are entirely temporary. They cannot currently be saved or shared or put on a dashboard, though this functionality is coming soon.

Explore tab summaries can be grouped and aggregated based on only the displayed PAF columns, not those listed as "Available" in the Display tab

REPORTING and ANALYTICS – Recent Changes to SlicerDicer – list below:

Erroneous filters removed from SlicerDicer Births data model. These filters are not used at AHS and do not return data when used in SlicerDicer.

SlicerDicer now makes it easier to differentiate between Stollery and non-Stollery patients in the Admissions and Visits data models. The *Stollery Children's Department?* filter in the Admissions and Visits data models allows you to easily include or exclude Stollery Children's Departments from your population. With the Stollery Children's Hospital and UofA in the same Revenue Location, it was difficult to differentiate between the two hospitals.

You can use the new *Stollery Children's Department?* filter in the Population section or as a Slice. Including the filter in the population section will include only departments where Stollery Children's Department = Yes. Using the Stollery Children's Department? filter in the Slice section will categorize the population into two groups: Stollery Children's Department = Yes and Stollery Children's Department = No.

The *Stollery Children's Department?* replaces the Center filter and is the source for accurate identification of Stollery and non-Stollery departments. The Center filter is no longer available for selection within SlicerDicer and is not supported by the AHS facility structure.

First Billed Date is now available in the SlicerDicer Hospital Accounts (HB) data model. You can now define your date range by First Billed Date in the Hospital Accounts (HB) data model. To define your query by First Billed Date go to the Dates section and select Based On → First Billed Date. When this selection is made the query will use the First Billed Date when you modify the date range.

Other available date selections in the Hospital Accounts (HB) data model include: Admit Date, Close Date, Discharge Date, First Claim Date, Open/Closed in Range, and Zero Active AR Date.

Revenue Location is now available as a SlicerDicer filter in the Surgeries and Invasive Procedures data model. The Surgeries and Invasive Procedures data model now includes a Revenue Location filter. Using this filter you can now refine your population to a specific Revenue Location or categorize your population by Revenue Location in adding a Slice.
