

Thank you for your time and dedication working with our clinical clerks during their internal medicine MTU and subspecialty rotations. You are an invaluable part of their journey to becoming thoughtful, well-rounded physicians we will be proud to have as colleagues.

We have developed specific MTU and subspecialty rotation objectives for our clinical clerks. In addition, the UME has developed the "Big 10" learning objectives, which are objectives that all medical students should achieve at the end of their three years of training. These objectives are a way of ensuring we are providing high quality, standardized learning opportunities appropriate to the level of our clerks. In addition, they help anchor our assessment of their performance with respect to ITERs and EPAs.

CUMMING SCHOOL OF MEDICINE – "BIG 10" EDUCATIONAL OBJECTIVES

- 1. Demonstrate the basic science and clinical science knowledge and skills necessary for the supervised practice of medicine, and use knowledge efficiently in the analysis and solution of clinical presentations.
- 2. Evaluate patients and properly manage their medical problems by;
 - a. Conducting a comprehensive history and thorough physical examination; reliably eliciting appropriate information in the history and detecting abnormal findings on the physical examination.
 - b. Correctly identifying the patient's diagnosis, differential diagnosis, and medical problems.
 - c. Applying an appropriate clinical reasoning process to the patient's problems.
 - d. Advocating for patients while formulating and implementing a resource-conscious management plan to deal effectively with patient problems.
 - e. Applying basic patient safety principles.

- 3. Apply a comprehensive patient-centred approach in the evaluation and care of patients including sensitivity to differing: Mentation and gender identity, cultural and spiritual beliefs, attitudes and behaviors, economic situations.
- Demonstrate knowledge of the fundamental concepts of disease prevention and health promotion for individual patients and populations and incorporate them into treatment plans as appropriate.
- 5. Communicate and interact effectively with patients, families, medical staff and others involved in the delivery of health services.
- 6. Describe and apply ethical principles and high standards in all aspects of medical practice.
- Exhibit appropriate professional behavior, including awareness of personal Wellness and limitations.
- 8. Formulate clear clinical questions and apply an evidence-based approach to solving these questions.
- 9. Demonstrate educational initiative and self-directed lifelong learning skills.
- 10. Describe the basic principles of clinical and translational research, including how such research is conducted, evaluated, explained to patients and applied to patient care.

Transition to practice session

Alberta Innovates, AHS and the Grant Development Office are hosting an information session for University of Calgary researchers on the upcoming Partnership for Research and Innovation in the Health System (PRIHS) 8 competition, which will launch on April 3, 2023. Representatives from the SCNs and Integrated Provincial Programs, as well as the PRIHS working group, will be available to share program highlights and answer questions. Clint Westgard, from the Grant Development Office, will highlight internal timelines and support available for applicants.

The PRIHS is designed to align research with the evidence needs of the health system through projects focused on the implementation of promising solutions to priority health system challenges in collaboration with Strategic Clinical Networks (SCNs). Projects should propose solutions that are aligned with SCN priority areas and improve healthcare quality, health outcomes and overall value for Albertans in acute, primary/ambulatory, and/or community-based settings. CIHR NATIONAL WOMEN'S HEALTH RESEARCH INITIATIVE (NWHRI): BIOMEDICAL DISCOVERY GRANT

Through <u>Canada's Biomanufacturing and Life Sciences Strategy (the Strategy)</u>, the Government of Canada is investing more than \$2.2 billion over seven years to continue growing a strong, competitive biomanufacturing and life sciences sector, and to ensure Canada is prepared for future pandemics by increasing domestic capacity through investments and partnerships to produce life-saving vaccines and therapeutics.

The <u>Canada Biomedical Research Fund and Biosciences Research Infrastructure Fund — Stage 2</u> funding opportunity (CBRF-BRIF) proposals can include one or more of the following components:

- 1. Partnered, applied research in the biomanufacturing and life sciences sector to accelerate the translation of discoveries into products and services to strengthen the sector.
- 2. Partnered talent development to provide skills and training needed to drive innovation and growth in Canada's biomanufacturing industry (linked with eligible research).
- 3. Research infrastructure to support Canada's biosciences research needs (linked with eligible research).

CBRF funding will provide support of \$500k-\$5M/year for up to four years (including indirect costs). BRIF, through the Canada Foundation for Innovation, will fund up to 60% of eligible research infrastructure costs with a minimum request of \$1M/project. (Note that BRIF requests must be linked with eligible CBRF projects.)

Competition parameters are complex. Contact ipd@ucalgary.ca as soon as possible if interested in applying to discuss next steps. This will allow UCalgary to coordinate projects (as required) and support necessary connections with hubs.

CANADA LUNG ASSOCIATION ALLIED HEALTH RESEARCH GRANT

The objective of the Canadian Lung Association: Allied Health Grant is to promote research in areas that contribute to the field of respiratory health in Canada. Studies should include research related to an applied or clinical question using quantitative or qualitative methodologies. The study may include a basic science component, but the primary research questions must be applied or clinically focused.

The Allied Health Operating grant is based on a 50:50 match formula between the Canadian Lung Association and the Principal Investigator. The matching funds can include funding from active operating grants, PI's department or institution, and/or a research partner, including a Provincial Lung Association. The PI, department head, host institution, and/or a partner agency is required to provide written confirmation of the remaining funding - \$10,000 - for one (1) year.

CIHR APPLIED PUBLIC HEALTH CHAIRS

SSHRC RECONCILIATION NETWORK IN RESPONSE TO CALL TO ACTION 65

In response to the <u>Truth and Reconciliation Commission of Canada</u> (TRC) Call to Action 65, the Reconciliation Network in Response to Call to Action 65 is a joint initiative between the National Centre for Truth and Reconciliation and SSHRC. This unique opportunity supports establishment of a national research program with multiyear funding to advance collective understanding of reconciliation.

SSHRC and the NCTR invite teams led by First Nations, Métis Nation or Inuit researchers to submit proposals for new or existing formal partnerships that contribute to our collective understanding of truth and reconciliation. Teams can include any number of co-directors, co-applicants or collaborators, and must include at least one partner organization. Grants will provide support of up to \$200,000/year for partnerships over five years to advance research, research training and knowledge mobilization in the social sciences and humanities. ALBERTA LUNG – LUNG HEALTH RESEARCH GRANTS

The Lung Health Research Grants (LHRG) is a peer-reviewed competition that supports pulmonary research or development projects. Applications will be considered for research proposals that are directly relevant to human respiratory health.

CIHR, in collaboration with confirmed partners, has launched two strategic funding opportunities for brain health and cognitive impairment in aging. The goals of these funding opportunities are to: 1) Create knowledge about resilience in brain aging, identify and reduce risks that can result in cognitive impairment, and mobilize this knowledge to change approaches to brain health; 2) Improve care and services for people with cognitive impairment and dementia; and, 3) Develop, evaluate and implement strategies to improve the health and wellbeing of care givers and care providers.
